

**A CALL FOR NOMINATIONS
GVR METROPOLITAN DISTRICT**

TO WHOM IT MAY CONCERN, and, particularly, to the electors of the GVR Metropolitan District of the City and County of Denver, Colorado.

NOTICE IS HEREBY GIVEN that a mail ballot election will be held on the 8TH day of May, 2012, between the hours of 7:00 a.m. and 7:00 p.m. At that time, four directors will be elected to serve 4-year terms. Eligible electors of the District interested in serving on the board of directors may obtain a Self-Nomination and Acceptance form from the District's Assistant Designated Election Official: Micaela Duffy, GVR Administration Office, 18650 E. 45th Avenue, Denver, Colorado. The office of the Assistant DEO is open on the following days: Monday through Friday, from 8:00 a.m. to 5:00 p.m.

If the DEO, Sandy Thomas, determines that a Self-Nomination and Acceptance form is not sufficient, the eligible elector who submitted the form may amend the form once, at any time, prior to 3:00 p.m. on Friday, March 2, 2012. The deadline to submit a Self-Nomination and Acceptance Form is close of business on **Friday, March 2, 2012** (not less than 67 days before the election). Earlier submittal is encouraged as the deadline will not permit curing an insufficient form. Affidavit of Intent To Be A Write-In-Candidate forms must be submitted to the office of the Designated Election Official by the close of business on **Monday, March 5, 2012** (the sixty-fourth day before the election).

NOTICE IS FURTHER GIVEN, an application for a mail-in (absentee) ballot shall be filed with the Designated Election Official no later than the close of business on **Friday, May 4, 2012**, except that, if the applicant wishes to receive the mail-in (absentee) ballot by mail, the application shall be filed no later than the close of business on **Tuesday, May 1, 2012**.
