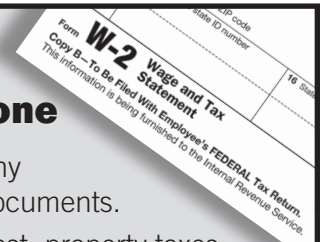

- Social Security Cards (or ITINs) for all family members. Photo I.D.
- A copy of last year's tax return, if available.
- Bank account number and routing number to direct deposit your refund. With direct deposit, refunds are received in just 7-10 days!

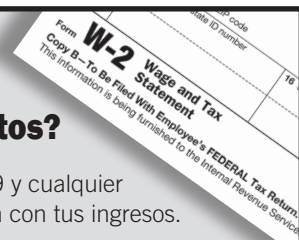

### ¿Qué debes traer para obtener tu declaración de impuestos?

- Todos los formularios W-2, 1099 y cualquier otra documentación relacionada con tus ingresos.
- Prueba de los intereses hipotecarios, impuestos sobre la propiedad, pago de guardería, contribuciones de caridad y todos los demás gastos deducibles de impuestos.
- Para los gastos universitarios: Además de la Forma 1098T de tu universidad, es importante llevar un registro personal de los gastos pagados por la matrícula, libros, cuotas y materiales.
- Tarjetas de Seguro Social (o ITIN) para todos los miembros de la familia. Identificación con foto.
- Una copia de la declaración de impuestos del año pasado, si está a tu alcance.
- Número de cuenta bancaria y número de ruta para depósito directo de tu reembolso. ¡Con el depósito directo, los reembolsos se reciben en tan sólo 7 a 10 días!

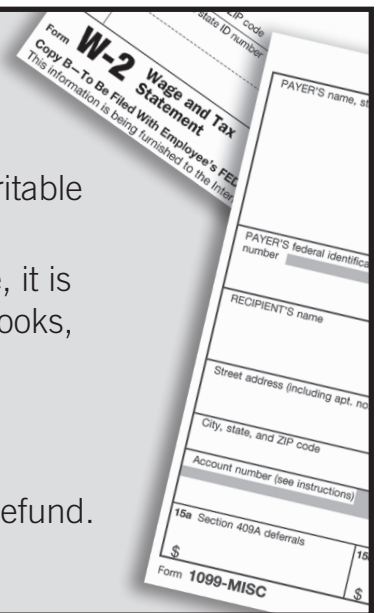
